The Thirteenth District Court of Appeals is seeking applicants for the position of Senior Attorney for Justice-Elect Leticia Hinojosa in the Edinburg office of the Court. Commitment terms are negotiable.

**Essential Job Functions:** Senior attorneys perform extensive legal research and writing and may plan, assign, and/or supervise the work of others. Duties include researching and writing memoranda on appeals and original proceedings, making recommendations on motions, making oral presentations to the court in conference, and performing routine administrative duties. Duties may include related work as required.

**Minimum Qualifications:** Graduation from an accredited law school with an LL.B or J.D. degree. Licensed to practice law in the State of Texas and an active member of the State Bar of Texas in good standing. Three to five years of prior legal experience. Knowledge of legal principles, practices, and proceedings. Skill in legal research, writing, and analysis. Ability to work independently and direct and supervise the work of others. Proficiency in computer and word processing skills and ability to communicate clearly and effectively.

**Preferred Qualifications:** Strong preference is given to candidates with outstanding academic records, demonstrated writing ability, law review or journal experience, moot court or mock trial experience, and prior work for an appellate court or other appellate experience.
